Church History

St John's Catholic Church, with roots dating back to 1919, has a rich history intertwined with the growth of the community. The parish's inaugural church traces its origins to 1873 when it served as the Valley School Building before becoming the Baptist church. In 1919, John Zeis, Sr. acquired this historic structure, relocating it to Alexander Street and Park Avenue, where it was established as the St. John Catholic Church.

A significant chapter in the church's history unfolded in 1965 when ground was broken for a new church at its present location. This marked the beginning of a new era, setting the stage for the spiritual home that stands today. In 1984, the church expanded with the addition of a social hall and religious education classrooms. The year 2007 witnessed further enhancements, including additions and updates to the social hall, entryway and worship space.

Continuing the tradition of growth and improvement, groundbreaking ceremonies in 2020 heralded the latest addition to the church. These ongoing efforts reflect the commitment of St. John's Catholic Church to serving its congregation and community, ensuring a welcoming space for worship, fellowship, and spiritual growth.

MASS MINISTRIES

Parishioners are encouraged and invited to share in these ministries.

To become involved, reach out to the parish office.

Extraordinary Ministries of Holy Communion (EMHC's)

are lay men and women who distribute the Body and Blood of Christ at Mass. They also take Holy Communion to shut-ins and the nursing homes.

Lector are lay men and women who proclaims the first and/or second reading at Mass. This person also may lead the Psalm (in the absence of a cantor) and the Prayers of the Faithful at Mass (in the absence of the deacon). A lector must have the qualifications listed below and have a desire to minister in this capacity at the Mass.

Altar Servers of the Parish are trained during their 4th grade year. Altar servers are scheduled monthly and should assume the responsibility of serving their appointed times or get a sub. They are expected and required to abide by the rules of reverence, respect, knowledge, accountability, appropriate dress, and manners.

Sacristans are lay people who prepare vessels, and see that everything is set up prior to Mass. They also assist with altar servers to make sure they are appropriately dressed and ready to serve for the mass on the Altar.

Ushers and Greeters are integral part of the Liturgy as they are the first people who are seen as worshippers enter the church for Mass. They greet people as they come in, help them to find seats if needed. Ushers, take up the collection and gifts, if necessary. They distribute bulletins after Mass.

FAITH FORMATION

There is something for all ages and stages of life here at St. John's.

Sunday School, tailored for Preschool and Kindergarten children, is offered during the Sunday 10:00am Mass. This early introduction to faith helps lay a foundation for their ongoing spiritual development.

Religious Education, every Wednesday evening, provides dynamic classes for students in 1st through 8th grades. This program not only imparts essential teachings but also includes Sacramental preparation for those reaching important milestones in their faith journey.

Youth Ministry, designed for high school students, offering a mix of monthly activities and an annual trip to the Catholic Steubenville Conference in the St. Louis area. These experiences help our youth connect, grow, and deepen their faith in a fun and engaging way.

Adult Formation programs include frequent Parish/Family events that foster community and connection, rotating Bible Studies that delve into the richness of scripture and guest speakers who bring unique perspectives and insights.

events to access assistance ranging from worship service information, facility questions, or medical and safety needs.

Members of St. Michael's Ministry act as the eyes and ears of the parish at Mass to watch out for parishioners in need, to answer questions, and to be observant for any unsafe condition or potential hazard to the people attending the service. St. Michael's Ministry members are not there to act as law enforcement but rather to communicate with 911, alert Father, provide assistance and secure the facility as much as possible in the event of an emergency.

You will meet members of this ministry with the greeters before Mass. They will spend some time during Mass in the vestibule and surrounding areas. Feel free to call on them during Mass or at any time, if you have or if you see an immediate need or have observed something you are concerned about.

The **Society of St. Vincent dePaul**

is an international Catholic volunteer organization dedicated to growing spiritually by helping people in need, regardless of faith, in the spirit of our patron, St. Vincent dePaul.



Our organization here at St. John's is a network of friends, inspired by Gospel values, growing in holiness by responding to requests for assistance that come through our Helpline and directly to the parish office. We prevent evictions by paying rent and help with utility bills to avoid disconnection. We help with car repairs and gas fill-ups so people can go to work. We provide food, clothing and furniture as we partner with the SvdP Stores in Omaha and through our partners, COPE and the Knights of Columbus. Our work is inspired by the words of Jesus, "Whatever you did for one of the least of my brothers you did for me..."

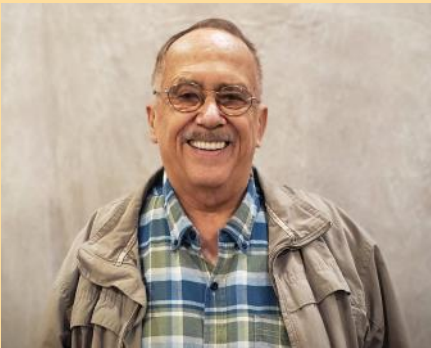
